A BRIEF NOTE ON VISIT TO MCI OFFICE IN DELHI FOR RELEASE OF MCI ELIGIBILITY CERTIFICATE FOR 2012 BATCH STUDENTS

It is happy to inform you all the parents and children of Liaoning Medical University that 'The Parents Association of Liaoning Medical University, China @ India' was registered as a Society in the Month of December, 2014, with Regd. No.1138/2014.

Our aim is to solve the problems of children who are studying in Liaoning Medical University, China. Most parents who got in touch with us expressed concern on non-receipt of MCI Eligibility Certificate of 2012 Batch students. Even after lapse of two and half years from filing date of applications, the delay in release of document from MCI was indeed a cause of worry for all of us, which prompted the Parents Association to immediately attend to this task, on high priority.

The members of the Association together with Medico broad discussed this issue comprehensively and arrived at the decision of sponsoring two members to visit MCI office in New Delhi to assess the correct status of applications of all students of 2012 Batch and try to work out any feasible solution. Medico Abroad provided us with complete data of all students like the MCI acknowledgement copies, the proof of re-filing the applications as per new format, and the lists comprising students' details with tracking nos. reflecting the status as shown in the MCI website. Broadly, the status of applications (as reflected on MCI website) of all 77 students of 2012 Batch falls under following three categories:

- i. First category those who were said to have been issued Eligibility
 Certificate 19 nos.
- ii. Second category those whose payments were said to be verified and waiting for release of Eligibility certificate 50 nos., and
- iii. Third category where no information is posted 8 nos.

I, S.Narender, General Secretary and Shri D.Rajaiah, Treasurer volunteered for this task and taking 3 sets of all the above details, we immediately proceeded to Delhi by train, on the thick winter day of 11th Jan, 2015. After 36 hours delayed journey, we could reach Delhi only by the night of 12th Jan, so left with precisely two working days on hand, due to festival holidays that followed.

On 13th Jan morning, on reaching the MCI office, we met the concerned Section Officer dealing with Eligibility Certificate. Luckily, the officer was considerate and helpful. Though initially she suspected us as Agents approaching on behalf of parents, on producing evidence of formation of Parents Association such as the registration certificate, letterhead and our visiting cards, we could establish our genuineness, and then explained the purpose of our visit. From the details produced by us, the officer randomly verified the status of few applications in website and then called for those files, one after the other. To our surprise, it was taking not less than half an hour to locate and bring any file to the officer's table. As many others like us were waiting on same purpose and entire building is under surveillance of CC cameras, we were constrained to take exit after representing one case and then re-enter after little gap for representing another student. Thus we could hardly cover 8 files that day. The disturbing fact that revealed was that in the second category of applications whose status shows payment verified, the Demand drafts for Rs.1,000/- and Rs.100/- enclosed with applications either expired (not presented within validity period) or missing, and these files were kept marked for seeking fresh DDs. Communication was said to have been sent to parents' address but no office copy in the file. At the end of that day, we could conclude the status being reflected against tracking nos. in MCI website is not matching with ground reality. On our earnest requests, the officer updated the status of third category of applications and merged them with the second category.

Returning to the hotel in the evening, we contacted the other members and Medico Abroad and drawn a plan of action for the next day. On 14th Jan, soon as we met the officer, we requested her to reissue the Eligibility certificate for applications of first category which were said to have already been delivered. The officer obliged and sought request letters on behalf of the concerned parents and students, and also sought fresh e-mail Ids for sending the username and password. We immediately contacted Medico Abroad and took few mail Ids from them and adding our own personal mail Ids, we filed the request letters for the first category applications. Now, for the rest of the applications, obliging our requests, the officer received the entire list, acknowledgement copies and related details that we furnished. However, to process the same, she prescribed the following documents to be produced compulsorily.

- 1. Student Visa Copy (latest)
- 2. Student Passport Copy (photo page & address page)
- 3. Student I.D. copy (photo page)
- 4. Latest Fees paid receipt (issued by LMU)

- 5. Marks list of the student (of latest Sem at LMU)
- 6. D.D for Rs.1000/- and Rs.100/- (if necessary)

Before leaving the MCI Office, both I and Mr.Rajaiah, in the status of parents, filed some of the above documents available with us for release of Eligibility Certificate of our own children whose applications were also in the Second category. We were assured of issuance of Eligibility certificate in couple of weeks time. We returned back by 15th Jan and waited for the result.

As we were apprehensive of the result, we could not come out with all the above details till the certificates got released in our own case and that of the first category. Thankfully, in the first week of February, 2015, we find the issuance of the Eligibility Certificate for the following students.

Thus, a total of 17 students obtained Eligibility Certificate in 2012 Batch, and 60 students are yet to receive it. As our efforts have yielded result in bringing Eligibility Certificate for above 13 students, we believe the submission of prescribed documents will solve the matter for rest of them. We advise that soon as the university reopens, let the students obtain latest fees receipt and marks sheets from university and send the scan copies to our official mail Id, by the deadline date of 20th March, 2015. Apart from the said documents, we seek each student to submit us the following:

- A fresh mail Id and also its password (as we too will be checking their mail for receipt of MCI communication).
- 2. A valid phone number in India (as message is sent by MCI to mobile phone)

On receipt of the above details, we will obtain signatures of all the 60 parents authorizing us on their behalf to submit your respective documents at MCI office, and plan to travel once again to Delhi by first week of April, 2015. Hope you will appreciate the efforts of Parents Association and extend your co-operation in resolving the issue at the earliest.
